

## **MOSTYN LAW’S “KICKS AND COMPUTERS” OFFICIAL CONTEST RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN.

### **CONTEST DESCRIPTION**

Mostyn Law’s “KICKS AND COMPUTERS” Contest (“Contest”) will begin at 12:01 AM Central on July 6, 2026, and end at 2:00 PM Central on July 31, 2026 (“Contest Period”). Contest is sponsored by Mostyn Law (“Sponsor”) and administrated by Mostyn Law (“Administrator”). The Contest Administrator and Sponsor reserve the right to extend or shorten the Contest Period at their sole discretion. The Contest will be conducted exclusively online via registration at [www.mostynlaw.com/bts](http://www.mostynlaw.com/bts). Forty (40) winners — twenty (20) from Majic 102.1 FM and twenty (20) from 97.9 The Box — selected by a judging panel assembled by the Administrator, who will review all nominated students through the online registration form, will each be awarded one (1) laptop and one (1) \$200 Hibbett Sports gift card. The odds of winning depend on the total number of nominations received. Radio stations KMJQ-FM Majic 102.1 and KBXX-FM 97.9 The Box are solely the promoters of the Contest and not the prize providers.

### **HOW TO ENTER**

Legal residents of the Greater Houston area, who reside within one hundred (100) miles of Houston’s City Hall, in any direction, and who are 18 years of age or older at the time of registration, will be able to take part in the Contest. To participate in the Contest, participants must do the following:

1. Nominate a local student by completing the entry information requested on the Contest page at [www.mostynlaw.com/bts](http://www.mostynlaw.com/bts) by the submission deadline.
2. Registrants may nominate only one student at a time during the Contest Period.
3. By submitting a nomination, the participant affirms they are the legal guardian of the nominated student or have received express permission from the student’s parent or legal guardian to submit their information for consideration.
4. By entering the Contest, each participant agrees to be bound by the Official Contest Rules.
5. In the event of a dispute regarding the identity of a registrant and/or their nominee, the entry will be deemed to have been made by the authorized holder of the email account at the time the registration was completed.

### **ELIGIBILITY RESTRICTIONS**

1. Nominations may be made by legal residents of the Greater Houston area, who reside within one hundred (100) miles of Houston’s City Hall, in any direction, and who are 18 years of age or older at the time of Contest registration.
2. The nominees must be school-age students enrolled for the 2026–2027 academic year and

residing within the same area.

3. Employees of Mostyn Law, its officers, directors, subsidiaries, affiliates, general sponsors, promotional partners, their respective subsidiaries, affiliates, parent companies, and members of the immediate families (defined as spouse, child, sibling, parent, or grandparent), and members of their households (whether related or not) of any of the above are NOT eligible to participate or win in the Contest. These eligibility restrictions also apply to employees of Mostyn Law's radio partners and any retail sponsor participating in the Contest.

4. Entrants agree to abide by all applicable federal, state, and local laws and regulations.

## **PRIZES**

1. If a winner is unable to accept the prize, or attend the event the prize will be forfeited in its entirety, and another winner may be selected at the discretion of the Contest Sponsor.

2. The forty (40) grand prizes will each consist of:

- One (1) laptop computer

- One (1) \$200 Hibbett Sports gift card to spend in store or online

3. No substitution or redirection of the prize is offered, except as determined by the Contest Administrator or Sponsor in their sole discretion.

4. The grand prizes will be awarded only upon winner verification, confirmation of the elements, claims and facts noted in their nomination, and final approval by the Contest Administrator. The grand prize winner will be notified by phone or text within three (3) hours after being selected. The grand prize winner will then have 30 minutes to confirm their acceptance of the prize. If a winner or selected entrant is unable to be contacted during that period, is ineligible, or fails to claim a prize, the prize will be forfeited and, if time permits, an alternate entrant may be selected.

5. If a winner is unable to attend the giveaway event on August 1, 2026, no arrangements will be made to coordinate prize pickup or delivery directly with the Contest Administrator.

## **EXECUTION**

1. The grand prize winners will be declared following a review by a judging panel within 12 hours of the end of the Contest Period.

2. The nominator of each grand prize winner will be notified by email and/or by phone, prior to the public announcement.
