

MOSTYN LAW'S "DIFFERENCE MAKERS IN EDUCATION" OFFICIAL CONTEST RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

CONTEST DESCRIPTION:

Mostyn Law's "Difference Makers in Education" Contest ("Contest") will begin at 12:01 AM Central on September 7, 2026, and end at 2:00 PM Central on September 27, 2026 ("Contest Period"). The contest is sponsored ("Sponsor") and administrated by N by Mostyn Law, through its Marketing Department ("Administrator"). The Contest Administrator and Sponsor reserve the right to extend or shorten the Contest Period at their sole discretion. This Contest will be conducted exclusively online via registration at www.mostynlaw.com/edu. Twenty (20) winners, selected by a judging panel assembled by the Administrator who will review all educators nominated through the online registration form, will be awarded \$200 payable by check, a \$100 gift card to a Houston restaurant, and a commemorative plaque. The odds of winning depend on the total number of nominations received. Radio station KBXX-FM 97.9 The Box is solely the promoter of this contest and not the prize provider.

HOW TO ENTER:

Legal residents of the greater Houston area, who reside within one hundred (100) miles of Houston's City Hall, in any direction, and who are 18 years of age or older at the time of registration will be able to take part in this Contest. To participate in the Contest, participants must do the following:

1. Registrants must nominate a teacher, professor, instructor, counselor, coach, librarian, principal, vice-principal, dean, or headmaster, currently employed by a school district, college, or university serving students within 100 miles of Houston's City Hall in any direction. Nominations must be made by completing the entry information requested on the Contest page at www.mostynlaw.com/edu by the submission deadline to be considered by the judging panel assembled by Contest administrator.
2. Registrants may nominate more than one educator during the Contest Period.
3. By entering this Contest, each participant agrees to be bound by the Official Contest rules.
4. In the event of a dispute regarding the identity of a registrant and/or a winner, the entry will be deemed to have been made by the authorized holder of the email account at the time the registration was completed.

ELIGIBILITY RESTRICTIONS:

1. Nominations may be made by legal residents of the greater Houston area, who reside within one hundred (100) miles of Houston's City Hall, in any direction, and who are 18 years of age or older at the time of Contest registration.

The nominees must be currently employed as teachers, professors, instructors, counselors, coaches, librarians, principals, vice-principals, deans, or headmasters, at a school district, college, or university serving students within 100 miles of Houston's City Hall in any direction. This Contest is open to educators at the K-12, collegiate, and university level; it is not open to educators at trade or vocational schools.

2. Employees of Mostyn Law, its officers, directors, subsidiaries, affiliates, general sponsors, promotional partners, their respective subsidiaries, affiliates, parent companies, and members of the immediate families (defined as spouse, child, sibling, parent, or grandparent), and members of their households (whether related or not) of any of the above are NOT eligible to participate or win in this Contest. These eligibility restrictions also apply to employees of Mostyn Law's radio partners and the restaurant and retailers participating in this Contest.

3. Participants and winners agree to abide with any applicable federal, state, local laws, and regulations.

PRIZES:

1. If a winner is unable to accept his/her prize, the prize will be forfeited in its entirety, and an alternate winner may be randomly selected at the discretion of the Contest sponsor.

2. The twenty (20) grand prizes will each consist of \$200 payable by check, a \$100 gift card to a local restaurant, and a commemorative plaque. The estimated retail value of each prize package is \$350 USD.

3. No substitution of the prizes is offered, and the gift cards may not be redeemed for cash value, except as determined by the Contest Administrator or Sponsor in their sole discretion. Gift cards are subject to the use and restrictions identified by the companies that issued them.

4. The grand prizes will be awarded only upon winner verification and final approval by the Contest Administrator. The grand prize winners will be notified by email and/or phone within three (3) days after being selected (e.g., date of selection). Winners should expect to be contacted by telephone as part of this notification and verification process, and are encouraged to provide a valid, monitored phone number and to be available to answer such calls. The Contest Administrator and/or Contest Sponsor reserve the sole discretion to move on to an alternate entrant after a single unsuccessful attempt to contact a selected winner. If a winner is unable to be contacted, is ineligible, or fails to claim a prize, that prize will be forfeited and, if time permits, at the discretion of the Contest Sponsor and/or Contest Administrator, an alternate entrant may be randomly selected as a grand prize winner from the remaining entries.
